II. OFFICER REPORTS

Secretary's Report:

Treasurer's Report:

President Elect's Report:

A conversation was held about a "task master" position. Craig stated that is in the Secretary job duties. The struggle we face is waiting on final decisions and the process to get to those final decisions. Business Manager Report:

Mike Fleming reported that we have \$222,486 in beer sales YTD. Last year we were at \$212,857, so we are right on track. Chase Hawks coming up, and we gross usually about

\$16k. There are three basketball games coming up along with the Harlem Globe Trotters. The Mate Show is in February. PBR is coming up, with only two days this year instead of three (Saturday and Sunday). We have a comedian coming in April. RServing is still an issue with some people. The overdue RServes are: Adam Decker, Kris Koessl, Ashley Harada, Nate Allie (his was due in May), and Daryl Webber. Bare Knuckles garnered \$7,000.

President's Report:

The Flathead club wants to borrow the trailer again. The deposit is \$50. A motion was made by Craig to approve, and a second given by Chuck; the motion passed unanimously. There are two members that are still on the roster - Hilary Lee and Erik Hefner. Craig moved to remove Hillary and Erik officially. The motion was seconded by Chuck, and the motion passed unanimously. Some other outstanding issues from members of the club that need discussion are: Krystal Kelly, who no-showed but is not behind on her dues. Brad Kimble was previously marked off the list because he hadn't completed r-serving. Per Mike, he has now completed his R Serving. Al Jones requested to be removed from scheduling due to health issues. Dan Singer was previously marked as 'do not schedule,' but he is better now. Regarding the Festival of Trees table, we need 8 people to fill the table (Shawnee, Ed, and Teal with plus ones will fill 6 spots. We need two more which will go to club members at breakfast). New shirts are on the way per Craig as we are out of stock.
